

GPRA Qualtrics Reporting at a Glance

To assist with organizing GPRA PPW MI-CAFS reporting using WSU Qualtrics Link. PPW MI-CAFS GPRA data are to be collected face-to-face for each individual client at these specific points: **Intake (Baseline), Discharge, and 6MFUP**. Residential programs must collect GPRA data immediately, but not later than 3-days after the client officially enters the OUD/SUD treatment program. The following information may help organize and plan clinician engagement for each instance. It is recommended that clinicians read through the sections they need to cover prior to interview.

Note: Client Information:

-Please remember to use the same **Client ID** throughout the GPRA reporting process. Qualtrics will ask for the **Client ID** twice, you cannot move forward without it, so if you get an error message, please check that you have entered the correct **Client ID**.

-Remember to enter **Client Type:** Treatment Client or Client in Recovery

-Remember to indicate **GPRA Interview Type:** Intake, 6-Month FUP, or Discharge
