Common Q&As:

What if I can't reach my client for the discharge GPRA?

Submit an administrative discharge.
 It only asks questions known by the provider, such as the types of services that were provided.

I can't get back to the beginning of the GPRA survey, what do I do?

How will the WSU Evaluation Team conduct 6MFUs with clients who are incarcerated?

 More information is coming soon on how our team will complete 6MFU GPRA among clients who are incarcerated.

Reminder:

Recipients **must** enter GPRA in Qualtrics within 1 day – but **no later than 7 days** after it is completed. <u>This also applies</u> to agencies using paper surveys. The paper GPRA must be submitted in Qualtrics within 7 days of completing it.

Key Update Reminders:

The biggest change from SOR 3 to SOR 4 is...

Wayne State University
 Evaluation (WSU) Team
 completes 6-month follow-up
 (6MFU) GPRA!

A Limited Release of Information form must be completed at intake. This is programmed directly into the Qualtrics survey.

 While clients maintain the right to refuse to provide contact information, it will negatively impact the 6MFU rate.

Only one set of GPRA are required per client, per agency.

If a client returns for SOR 4
funded services through the
same agency, they do not
need to do another set of
GPRA.

More Info on Key Updates:

People conducting GPRA with SOR 4 agencies are only responsible for intake and discharge GPRA, not 6MFU.

The WSU Evaluation Team will conduct 6MFU GPRA and distribute gift card incentives.

Collecting client contact information is required for WSU to conduct 6MFU GPRA with clients, which includes:

- First & Last Name
- Phone Number
- Permanent Address
- Email Address
- One collateral contact's (trusted friend/family, etc.) name and phone number in case the client cannot be reached.

Nothing will be shared about the client, including an association with treatment/recovery services.

Multiple sets of GPRA are **not**required for SOR 4 clients returning
to the same agency.
GPRA are required for a client's **initial**engagement with SOR-funded
services at an agency.

A new set of GPRA are not required if a client returns to the same agency for services.

Only one set of GPRA are required for a client receiving SOR 4 funded services per agency.
