#### **Important Dates:**

**Sunday, September 29:** The last day to compete **SOR 3** GPRA with clients

Monday, September 30: NO SOR 3 or 4 funds are available.

Tuesday, October 1: The firstday to provide clients with SOR4 funded services andcomplete intake GPRA

**Tuesday, October 15:** The last day to submit **all SOR 3** GPRA online.

#### **Reminder:**

Recipients **must** enter GPRA in Qualtrics within 1 day – but **no later than 7 days** after it is completed. <u>This also applies</u> **to agencies using paper surveys**. The paper GPRA must be submitted in Qualtrics within 7 days of completing it. If a client is continuing services from SOR 3 to SOR 4, please note the following:

- New intakes for continuing clients should be completed the first time seeing a client since the transition of funding.
- If a client had a SOR 3 intake GPRA in September, you only need to provide the <u>SOR 3 Client ID</u> & intake date, and <u>SOR 4 intake</u> <u>date</u>. You will not have to conduct a new intake GPRA for SOR 4.
- If the client's SOR 3 intake was conducted <u>BEFORE</u>
  <u>September 1st</u>, a new intake will be required for SOR 4.

# Key Changes from SOR 3 to SOR 4:

People conducting GPRA with SOR 4 agencies are only responsible for **intake and discharge GPRA, not 6MFU.** 

The Wayne State University (WSU) Evaluation Team will conduct 6month follow-up (6MFU) GPRA and distribute gift card incentives.

Collecting client contact information is required for WSU to conduct 6MFU GPRA with clients, which includes:

- First & Last Name
- Phone Number
- Permanent Address
- Email Address
- One collateral contact's (trusted friend/family, etc.) name and phone number in case the client cannot be reached.

Nothing will be shared about the client, including an association with treatment/recovery services.

Multiple sets of GPRA are **not required** for SOR 4 clients returning to the same agency. GPRA are required for a client's **initial engagement** with SOR-funded services at an agency.

A new set of GPRA are not required if a client returns to the **same agency** for services.

**Only one set** of GPRA are required for a client receiving SOR 4 funded services per agency.

### Beginning in October:

SOR 4 GPRA Trainings will be on the **third Wednesday** every month from **11 AM to 12 PM** 

SOR 4 GPRA Q&A Calls will be on the **third Thursday** every month from **11 AM to 11:30 AM** 

\*Previously trainings were on Thursdays and Q&A Calls were on Wednesdays.

The trainings do not apply to: ITC, ITC-NAS, MDOC Peers, and the Saginaw Chippewa Indian Tribe.
