## Common Q&As:

### Who do I contact for GPRA corrections?

- Please email us at [GPRA@wayne.edu](mailto:GPRA@wayne.edu) for any GPRA data corrections, if you did not submit errors in the question at the end of the GPRA survey.

### I can't get back to the beginning of the GPRA survey, what do I do?

- Clear your browser's cookies!

### How do I know which treatment/recovery services are funded by SOR 4 at my agency?

- You must communicate with a higher-level staff person at your agency to specify which services are funded by SOR 4. Funded services vary by agency.

## GPRA Timeline:

Recipients **must** enter GPRA in Qualtrics within 1 day – but **no later than 7 days** after it is completed. **This especially applies to agencies using paper surveys.** The paper GPRA must be submitted in Qualtrics within 7 days of completing it.

- At the end of the GPRA survey please enter any errors in the open-ended text box. Reach out via email for additional errors/correction requests.

## Key Update

### Reminders:

The Wayne State University (WSU) Evaluation Team completes 6-month follow-up (6MFU) GPRA!

- More information regarding clients who are incarcerated at the time of 6MFU will be shared in the coming months.

**A Limited Release of Information (LROI) form must be completed at intake. This is programmed directly into the Qualtrics survey.**

- While clients maintain the right to refuse to provide contact information, it will negatively impact the 6MFU rate.
- A paper copy of the LROI is available on our website for agencies using paper surveys.

**Only one set of GPRA are required per client, per agency.**

- If a client returns for SOR 4 funded services through the same agency, they do not need to do another set of GPRA.
